MEMORANDUM OF UNDERSTANDING BETWEEN VILLAGE OF FREDONIA AND

CSEA, LOCAL 1000, AFSCME, AFL-CIO VILLAGE OF FREDONIA UNIT 6313 LOCAL 807

ESPERSEN/WANDEL

WHEREAS, the Village of Fredonia ("Village") and CSEA Local 1000, AFSCME, AFL-CIO, Village of Fredonia Unit 6313 Local 807 ("CSEA") are parties to a collective bargaining agreement ("Contract"); and

WHEREAS, there are been misunderstandings with the delivery and processing of grievances between the parties; and

WHEREAS, the parties would like to address the misunderstandings.

NOW THEREFORE, the parties agree to the following clarifications:

- 1. The first stage of the grievance procedure set forth in Section 20.01 of the Contract allows for the grievant to discuss the grievance with the immediate supervisor. Therefore, the grievant and/or CSEA will provide a written grievance to the direct supervisor. If the direct supervisor is the DPW Supervisor, the grievant and/or CSEA will deliver the written grievance by:
- a. Leaving the grievance taped on the window of the DPW Office in an envelope marked "Confidential-[DPW SUPERVISOR NAME]." The envelope should be time-stamped. The grievant/CSEA can get the envelope with the grievance time-stamped by the DPW Clerk or, if unavailable, Village Clerk or Village Treasurer; or

b. Leaving the grievance in a lockbox in the DPW Office that the Village intends to purchase and install.

Once the lockbox is provided, all grievances submitted to the DPW Supervisor will be placed in the lockbox with a timestamp as specified above. The grievance will be delivered ten (10) working days after the aggrieved party knew or should have known of the acts and conditions on which the alleged grievance is based.

- 2. The immediate supervisor will discuss and answer the grievance.
- 3. If the grievance remains unresolved, it will move to the second stage of the grievance procedure as set forth in Section 20.01 of the Contract. The grievance will be submitted to the Village Treasurer within seven (7) working days after the discussion or response from the immediate supervisor. The Village Treasurer will respond to the grievance within ten (10) working days.
- 4. If the grievance remains unresolved, it will move to the third stage of the grievance procedure as set forth in Section 20.01 of the Contract.
- 5. Any questions or concerns regarding this process in this MOU will be discussed and addressed between CSEA (President or Labor Relations Specialist) and Village representatives (Village Treasurer, Personnel Committee & Mayor, or Village Attorney).

MEMORANDUM OF AGREEMENT BETWEEN VILLAGE OF FREDONIA AND

CSEA, LOCAL 1000, AFSCME, AFL-CIO VILLAGE OF FREDONIA UNIT 6313 LOCAL 807

SIRACUSE/ESPERSEN

WHEREAS, the Village of Fredonia ("Village") and CSEA Local 1000, AFSCME, AFL-CIO, Village of Fredonia Unit 6313 Local 807 ("CSEA") are parties to a collective bargaining agreement ("Contract"); and

WHEREAS, CSEA has filed a number of grievances claiming a violation of the overtime assignments to particular bargaining unit members; and

WHEREAS, the parties are desirous of resolving this matter and find it in their best interests to resolve the grievances without proceeding to arbitration.

NOW THEREFORE, the parties agree to the following:

- 6. The parties agree that the Village will pay the bargaining unit members listed in Attachment A the corresponding amounts representing overtime assignments that were not offered to the unit members in accordance with the collective bargaining agreement.
- 7. The parties further agree to execute the attached Memorandum of Understanding to address and clarify the grievance procedures and processes as required un the collective bargaining agreement.
